



SCPD - PICKLEBALL CLUB BOARD MEETING MINUTES SEPT. 8, 2025

- I. **Call to Order:** The meeting was called to order at 3:00 pm by Rich Allison.
- II. **Location:** Private Residence: 78676 Gorham Ln.
- III. **Attendance:** Rich Allison, Bob Briedis, Sandy Berk, Rick Dowdle, Taffy Golden, Vicky Harrison. Not in attendance were Tom Watson, Jeff Cohen, Devon Heckert

- IV. **Secretary Position** – Rick Dowdle was introduced by Mr. Allison. Rick was asked to introduce himself to the group. Rick indicated that he has lived in SCPD for the past 11 years full-time and worked in health care for 50 + years. He has held various administrative roles, representing the payer and the provider. Rick also was an adjunct faculty member teaching graduate school for 18 years at Cardinal Stritch University – Milwaukee, WI.
The board met privately and approved unanimously for Rick to be the new secretary. As a follow-up, an e-mail will go out to full membership asking to approve Rick to hold full voting rights as outlined in the bylaws. A 50% unanimous vote of membership is required.

The Minutes of May 5, 2025, were reviewed by the Board. There was a motion to approve the minutes as written by Ms. Berk, a second by Mr. Briedis, and there was a unanimous vote to approve the board minutes as presented.
- V. **The Treasurer’s Report** was prepared and presented by Mr. Briedis. Mr. Briedis reported a checking account balance of \$18,833 for the year ending of June 30, 2025, which remains the same on September 8, 2025. There was a motion to approve the treasurer’s report by Mr. Allison, a second by Ms. Berk, and a unanimous vote was carried to approve the report as written.
- VI. **Calendar- Events, Court Usage Schedule, Ladders, Clinics**
 1. **Calendar – Events:** Ms. Berk presented the Calendar of Events and suggested that this new Calendar would need to be posted to the Pickleball Bulletin.
 2. **Court Usage:** The following titles and times have been approved by the board.
 - i. **Morning Hours:** Monday through Friday 6:30 to 11:00 am “Drop in by Skill Level” All paddle and rotation rules apply during this time.
 - ii. **After Hours:** Monday through Friday – After 11:00 am “Rec Play” No paddle or rotation rules will apply.
 - iii. **Club Play:** Designated Club Play as sponsored by the Pickleball Club (i.e. mixers, ladders, lessons, ball machine. A complete listing of sponsored events will be posted in the Breezeway on the Pickleball Bulletin board.
 - iv. **Evening Court:** will include Couples and Mixed ladders. Wednesday and Thursday evening from 6 pm until 7:30 pm
 - v. **Clinics:** Pickleball Level clinics will be posted on the Pickleball Calendar of Events
