



**SCPD - PICKLEBALL CLUB
BOARD MEETING MINUTES
June 1, 2026**

- I. **Call to Order:** The meeting was called to order at 3:00 pm by Mr. Allison.
- II. **Meeting Location:** Private board member residence in Sun City Palm Desert, CA 92211.
- III. **Attendance:** Rich Allison, Rick Dowdle, Taffy Golden, Bob Briedis, Lisa Hadley
- IV. **The Minutes of May 4, 2026,** were reviewed by all. There was a motion by Mr. Briedis to approve the minutes as written and a second by Mr. Allison. There was a unanimous vote by the Board to approve the minutes as written.
- V. **The Treasurer's Report** was presented by Mr. Briedis. He reported a cash balance of \$18,475 as of May 31, 2026. Mr. Dowdle moved to approve the financial report as submitted, Mr. Allison seconded the motion, and the Board approved it unanimously. Mr. Briedis will prepare a year-end Pickleball club financial report to be submitted to the SCPD HOA. This report must be submitted by July 10th, 2026.
- VI. **Membership** was reported by Ms. Golden. The club had 563 paid members as of May 31, 2026. This number includes 113 new members to the club during the past fiscal year.
- VII. **The Transition of the assigned bank from the HOA Finance Department** to the Pickleball Club has not yet been finalized. Mr. Briedis and Mr. Allison will work to complete the process by the end of the week, if possible. The required forms must be completed, signed, and submitted to the bank. Signatures from the President and Treasurer must also be on file with the new bank for checking writing.
- VIII. **Ladders** – There was a brief discussion on the summer ladders. Ms. Golden suggested that “so far so good” and that players appear excited and cooperative with the summer play. There was discussion on the Fall ladders. The new model for Pickleball Ladders would include three (3) levels: (1) beginner/low intermediate, (2) intermediate, and (3) high intermediate / advanced and will be comprised of a mixed group. Team Captains still need to be selected.
- IX. **Pickleball - Semi-Annual meeting** is scheduled for October 26, 2026, at Speakers Hall.

Old Business

- X. **Software “Court Reserve”** – Ms. Hadley will arrange a conference call to discuss the potential software. The Zoom call is tentatively scheduled for June 3, at 11:00 am.

New Business

- XI. **A group of selected players** have asked for special play time and court designation. It was suggested that for any special consideration that all players must be members of the club and it may not be a closed panel of players.
